The Fund is aiming to achieve growth and investment in come from selected securities.

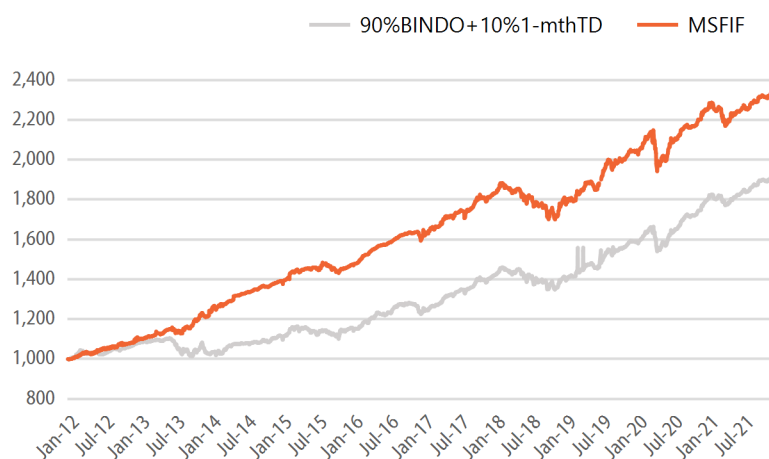
## Investment Strategy
