


Investment Objective

The fund aims to achieve a superior medium to long term capital gains in a low volatility environment through an actively managed portfolio of predominantly large cap, liquid Indonesian stocks. The Fund has a flexible asset allocation strategy and invests between 80% and 100% of its assets in equity securities and between 0% and 20% of its assets in money market instruments and/or debt securities.
